### EN 381-5:1995

Leg protection for users of hand-held chain saws. This product is designed to minimise the risk of/provide protection to the legs against accidental

contact with a hand-held chainsaw machine.

However, always remember that no item of PPE can provide full protection and care must always be taken while carrying out the risk-related activity.

#### Performance and Limitations of Use

The garment has been tested in accordance with EN 381-5:1995 for Design A, Class 1 performance (protection at linear chainsaw speeds up to 20 m/s).

Type A chainsaw trousers have protective chainsaw blocking material at the front of the legs only.

The garment is not designed to offer protection to the wearer against any other hazards eg against welding. chemicals, contact with an electric current.

If the product becomes damaged, it will NOT provide the optimum level of protection and therefore should be immediately replaced.

This product is no substitute for the safe operation of a chain saw and will not provide total protection.

#### Compatibility

To optimise protection in some instances it may be necessary to use the garment with suitable protective boots, gloves, helmet and ear defenders.

In this case, before carrying out the risk-related activity, consult your supplier to ensure that all your protective products are compatible and suitable for your application.

#### Fitting and Sizing

Only wear products of a suitable size. Garments that are either too loose or too tight will restrict movement and will not provide the optimum level of protection.

The size of the garment is marked on the label attached inside. The garment is available in the following sizes: S, M, L, XL, XXL, 3XL,

#### Repair

Do not attempt to repair damaged garments.

The trousers should be discarded and not used again if the leg protection has been:

- damaged
- incorrectly washed

- Altered from its' original shape. In these cases, the protective proprieties may be reduced.

Damaged outer material must be repaired immediately in order to prevent the leg protection from being damaged. If the outer material is being repaired, do not sew into the leg protection, which may reduce the protective properties.

However when the protective material is damaged, the garment must be discarded and replaced.

Adhesives should NOT be used in any repair as this may reduce the protective properties.

#### After Care:

After washing, make sure to stretch and reshape the garment before allowing it to dry.

Wash the garment regularly. Heavily soiled garments may offer less protection.

The manufacturer will not accept liability for garments where care labels have been ignored defaced or removed

#### Content label:

Refer to garment label for corresponding content details.

#### Storage and Transport:

When not in use, store the garment in a well-ventilated area away from the extremes of high temperature. Never place heavy items on top of the garment. If possible, avoid excessive folding and preferably store it hanging vertically.

If the garment is wet, allow it to dry fully before placing it into storage.

#### Wash Care Labels

Wash by machine or hand in cold water. Hang to dry.
