Application

Before applying maintanance oil clean the floor with Parquet Oil Cleaner to remove dirt and grease. Let the floor dry. Stir before use then apply a thin coat of Parquet Oil Refresh with a cloth. Within 15 - 20 minutes spread the product in an uniform way with a polishing machine with a soft pad. To get a brighter aspect, the day after polish with a soft cloth or a polishing machine.

Notes

- ✓ After oil treatment wait for 2 weeks before the first washing with Parquet Oil Cleaner
- ✓ Do not apply Parquet Oil Refresh on old varnishes, nitro-based sealers or similar
- ✓ Ventilate the room while oiling

✓ Drying times can be affected by ambient causes like high R.H. or low temperatures: in these cases the drying is slower

✓ For periodical maintenance the application of **Parquet Polisher** is recommended
